The 2000 Barolo Rocche has fared better than the Brunate, but it is a far cry from some of the truly legendary Rocches I have tasted here and elsewhere. The 2000 is rather burly Rocche, with little of the finesse that is this wine's calling card. Sweet mint and floral notes add freshness on the finish. Though not especially vibrant, the 2000 Rocche should last another decade or so on the strength of its fruit. Anticipated maturity: 2011-2020. Long-time readers know the late 1990s and early 2000s were a period of transition at Vietti. It was a time of experimentation with winemaking that led to the growth that now informs the spectacular wines of more recent vintages.

The 2000 enjoyed a stellar showing. Although it revealed many qualities that were reminiscent of the 1997, it also appeared to offer better balance and harmony as it was less obvious in its expression of the hot vintage.

Vietti is one of Barolo's historic properties. Husband and wife team Alfredo Currado and Luciana Vietti were pioneers in the 1960s. They were among the first producers to recognize the unique qualities of their vineyards, many of which are among the finest in the region, even today.

Vietti is one of the most representative estates in Piedmont, producing textbook wines from many of the region's most prestigious appellations. Luca Currado's philosophy is simple: each cru is vinified in the manner he feels best brings out that vineyard's character. The use of small barrels versus large, or new oak versus used varies from wine to wine.

To compare vintages, Currado opened up a 1999 Barolo Rocche, which was showing beautifully. An additional year of bottle age had done wonders for this delicate and aromatic Barolo that was soft, and caressing with a gorgeously elegant finish. Vietti also makes two of the best Barberas in Piedmont, Barbera d' Alba Scarrone Vigna Vecchia, and Barbera d'Asti La Crena, both of which are worth seeking out.

**About Maturity and Drink Dates:** Most reviews in The Wine Advocate include a period during which the wine should ideally be consumed. We express it as a range of years (Drink Dates) and we use that range to calculate a 'Maturity' for the wine as of the current date. Maturity values are: Young - the early drink date is in the future; Early - first third of the drink date range; Mature - middle third of the range; Late - last third of the range; Old - the late drink date is in the past.
